OFFICIAL PHOTO CONTEST RULES

Entry Guidelines:

- We are looking for photos that best represent the categories listed below. Entries can be submitted for multiple categories, but an entrant can only win in one category. All entries must be original works of the submitter.
- All entries must be in JPEG/300 dpi and a file size of: 330 x 2550 or 8.5 x 11. Color or monochrome images accepted. Entry Categories:

There will be six categories for entry, which include:

- Spring/Summer
- Fall/Winter
- Celebrations
- Generations/Families
- Community
- Youth [The Youth category is limited to entrants ages 18 and younger.]

Photos will be judged by an Iowa Farm Bureau Federation staff committee. The winning photos in each category will be those that best represent the category and positively reflect upon Iowa agriculture.

Entry Period:

Entries to the Photo Contest will be accepted from February 1, 2017 through August 1, 2017. The Photo Contest will close at 5:00 PM Central Standard Time on August 1, 2017. All photo entries for the Photo Contest must be received on or before the Photo Contest deadline to be eligible to win. Once submitted, entries will not be returned to entrants under any circumstances.

Eligibility:

The Photo Contest is open to Iowa Farm Bureau members only, regardless of age, gender, or nationality. Entrants under 18 years of age require the permission of a parent or guardian. Please have a parent sign the attached permission form and send in with your entry. The Photo Contest is void where prohibited by law. No purchase necessary. The Photo Contest is not open to directors, officers, and employees of the Iowa Farm Bureau Federation and its affiliated companies, and immediate family members of those individuals.

Awards and Prizes:

First and second place winners will be chosen from each category, and assigned the appropriate calendar month. Six (6) First Place winners will receive a \$100 cash prize and a 2018 Centennial Calendar. Six (6) Second Place winners will receive a \$50 cash prize and a 2018 Centennial Calendar.

Notification of Winners:

Winners will be notified in September of 2017. Any winner notification returned as undeliverable may result in prize forfeiture.
